A.R.S. 38-431.01 authorizes (but does not mandate) the City Council to make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, and to allow individuals to address the public body on any issue within the jurisdiction of the public body. The time will be limited to three (3) minutes per speaker. Those wishing to address the public body shall limit his or her remarks to issues within the jurisdiction of the public body. However, this forum shall not be used for making personal attacks or discussing personal issues directed to any individual member of the City Council or any other City employees.

The Tombstone City Council will hold a Budget Work Session to discuss the adoption of the Tentative Budget.



- A. **DISCUSSION AND/OR ACTION:** Approval of Accounts Payable in the amount of \$261,178.83 (May 1, 2022 through May 31, 2022) and Credit Card Payments in the amount of \$5,984.65 for the month of May, 2022.
- B. **DISCUSSION AND/OR ACTION:** Approval of Resolution No. 07-2022; a Resolution of the Mayor and Common Council of the City of Tombstone, Cochise County, Arizona for the adoption of the Tentative Budget of the City of Tombstone for the 2022-2023 fiscal year, adopting the estimated amounts required to meet the public expenses for the Fiscal Year 2022-2023, authorizing and directing publication of statement and schedules of the Tentative Budget.
